5. CORRESPONDENCE RECEIVED

We have been asked to feedback on proposals for changes to the Post Office at Starbucks. This forms an agenda item should Councilors wish to make comment.

We have been granted £1300 by the Police and Crime Commissioner for Staffordshire from the People Power Fund to improve security at Craythorne car park. The grant included money for new signage and lighting. Money needs to be spent by September 2016.

Email received from the Civil Enforcement Team at ESBC inviting us to take part in 'Clean for the Queen' a litter picking initiative as a birthday present for the Queen. I have proposed that we join in and try and get community support to litter pick on Saturday 5th March. This forms an agenda item as we will need to agree a meeting place and time.

Email received from Clive Baker regarding more bricks being stolen from the Station. PCSO Wells has been informed as we do have an idea of where they are.

We have been invited by Eton and Horninglow PC to take part in a locally based Councillor Training Course. I have advised we probably would want to take up some places. Date to be advised.

Following the successful CPI bid for footpaths walks leaflet, I met with Clive Baker and we talked through some minor amendments - feedback section added; typos corrected; recommended circular walk added. This forms an agenda item for discussion/approval.

Report of graffiti under the skate slope on Elizabeth Avenue. I have obtained photos of the graffiti which includes names of so called 'Rolleston Boys' and 'Rolleston Girls'. This has been reported to PCSO Wells as they are obviously local perpetrators. Some of the graffiti is obscene, and certainly offensive. Discussion required about the possible removal of the skate ramp as I also observed the metal sheets coming apart which could cause injury to the smaller children who use it as a slide.

Along with Cllrs Gooding and Robson, met with Nathan Barnett and John Deacon to commence the work along Brookside. Letter to local residents drafted informing of the work and the reason for it.

Blue Cross Equine Centre have said we can have manure and top soil for the Jubilee Orchard if we make a donation to them.

We have been asked to support a grant proposal to the Heritage Lottery Fund. This bid will include areas of Rolleston and we are asked what we think should be the key focus of the project, any areas of concern could be addressed, and if we have any other suggestions for the bid.
